# Summary of Current WAH Legislation

#### Ontario Regulation 297/13 (Occupational Health and Safety Awareness and Training)

Section 6- Application (Construction Projects/ Methods of Fall Protection listed)

#### Section 7- Employer duty to ensure worker has unexpired WAH training

Section 8- WAH training is valid for three years from date of last successful completion

#### Section 9- Fall protection training requirements under Section 26.2 of O. Reg. 213/91

Section 10- Training Record (Temporary and CPO-issued card)

Section 11- Transition (ending April, 2018)







# Construction Regulation <u>Two</u> Worker Training Records Required

Ontario Regulation 213/91, s. 26.2(1);

"An employer shall ensure that a worker who may use a fall protection system is adequately trained in its use and given adequate oral and written instructions by a competent person."

#### <u>and</u>

Ontario Regulation 213/91, s. 26.2(1.1);



"In addition to the requirements of subsection (1), an employer shall ensure that a worker who may use a fall protection system meets the working at heights training requirements of Ontario Regulation 297/13."



# What's Ahead in 2018-19? The Q4 Planning Cycle

**10-month Provincial Initiative on the Internal Responsibility System** <u>Focus</u>:

- Address constructor, employer, supervisor and worker duties
- Site H&S reps, JHSC's (availability, involvement)
- Project Owners + Directors (liability)
- Documentation such as NOPs, Form 1000s + other administration
- Address administration of workplace violence & harassment programs <u>Rationale</u>:
- SAWO consultative feedback has identified a systemic change is needed within organizations and workplaces to develop a safety culture.

Dates:

June 1, 2018 to March 31, 2019





# Looking Ahead (cont'd)

### **Provincial Blitz # 1: Working at Heights - Fall Protection Training**

Focus: O. Reg.213/91, s. 26.2, component-specific training

Rationale: to further build on the falls work undertaken to date, and to reinforce the MOL position that employers and supervisors must ensure their workers have been adequately trained on the components and application of the fall protection system being used at the time of the inspection/investigation.

Dates: TBD (1 month), likely in Q3





# Looking Ahead (cont'd)

### **Provincial Blitz # 2: Reversing Equipment on Construction Projects**

#### Focus:

O. Reg. 213/91 s. 104(1) and 106 for reversing vehicles

#### Rationale:

This is in response to the equipment fatalities in 2017. Ensure that workplace parties are accountable for proper reversing and signalling procedures.

Dates: TBD (1 month), likely in Q2


