1.0 Call to Order

• Meeting called to order at 12:10 pm

2.0 Safety Moment

- Revoking of Chapter funds. Carol Ann noted that all funds will be provided to National as chapter has been dissolved by National.
- Discussed reorganization of 7 Chapters into one Regional Chapter. Sean Budgell noted that the virtual meeting in December was all over the place and that no questions were answered, lots of going in circles.
- Update on CSSE reorganization timelines:

 - January 2023 Atlantic Chapters leadership discussions ongoing.

 - March 2023 Annual general meeting.
 - Mark Balsom noted that during COVID-19, CSSE members needed support from National on dealing with such an issue and nothing was provided by National to help members.
